

The School Building Committee
Middleboro High School – Career Center
April 15, 2015
Approved Minutes

The meeting was called to order at 6.31 PM by Chairman Rob Desrosiers. Members present were Paul Branagan, Rob Desrosiers, Ellen Driscoll, Allin Frawley, Brian Giavanoni, Alan Harris, Bob Nunes, Diane Stewart, Jennifer Wolfe, Jennifer Wrynn and Rich Young. Absent were Judy MacDonald, Kathleen Piatelli, George Randall and Robert Whalen. Also present was Colleen Lieb, Recording Secretary.

Chairman Desrosiers began the meeting with the review of the draft School District Educational Profile Questionnaire. It was noted that the Subcommittee did meet on April 9, 2015 to review the progress and provide input on the questionnaire. Member P. Branagan reviewed each page of the questionnaire and explained the detail that was provided in each section. There was a brief discussion on Page 2 regarding the Charter Schools and Private Schools listed. Member E. Driscoll spoke on the Information Technology portion of the application.

The Committee discussed the initial thoughts on moving Grade 8 to the High School. Member B. Giavanoni explained that this is really a preliminary idea that has not been discussed with the School Committee so it can be removed from the application at this time. The Committee discussed Page 6, which references changes to the High School to add the opportunity for the students to engage in vocational experiences.

The Committee discussed the April 28th deadline of the Enrollment Schedule Primer. It was noted that Kathy Piatelli has the enrollment information and can get that done. Member Rich Young agreed to contact Kathy to make sure that she moves forward on that. It was noted that this is a separate filing that has to be done online.

The Committee discussed the use of the Town site for emails for the Committee. Member Ellen Driscoll noted that she will work with the Town IT Department to get emails set up for everyone.

Member J. Wolfe presented to the Committee a Master Work Plan. She discussed with the Committee the timeline of what tasks need to be completed and notes that the dates need to be filled in. This is a working document and will evolve as the project progresses. Chairman Desrosiers noted that this will be put on the next agenda for discussion.

Motion is made by Member B. Givanoni and seconded by Member B. Nunes to approve the Draft Massachusetts School Building Authority School District Educational Profile Questionnaire as amended. All are in favor.

It is noted that the next meeting of the School Building Committee will be on Wednesday, May 6, 2015 at 6:30 PM at the Middleboro High School Career Center.

Motion is made by Member B. Givanoni and seconded by Member D. Stewart to adjourn at 7:30 PM. All are in favor.
