

Dear Friends on the Board of Selectmen,

I'm writing to ask if the Soule Homestead Education Center could use the back corner of the Town Hall parking lot on Saturday, November 3, 2012 for an electronics and appliance recycling event. We've held these events in the parking lot at Town Hall in spring and fall for several years now. We use CRT Recycling in Brockton as our licensed recycling company. We will accept electronics and appliances only (no hazardous waste). We'll leave the place cleaner than we found it.

We'd like to set it up as we have in the past. Between 10am and 2pm recycling traffic would enter the back corner of the lot by the handicap ramp, circle toward the Veterans Memorial, unload into the CRT truck on the far side of the lot and exit along that side. This layout would have little impact on the larger section of the parking lot and allow for easy traffic flow.
