

Middleborough High School Program Goals


Scores of 3 or Greater

Blue column: projected performance (qualifying scores) goals




Highlights

➤ Increase Participation:

- Two Year Growth of 177 Student Enrollments in AP Math, Science and English (+590%)
 - 13X the number of English Enrollments
 - 8X the number of Mathematics Enrollments
 - 4X the number of Science Enrollments

➤ Increase Performance:

- An Increase from 19 to 51 Qualifying Scores in Math, Science and English (+168%)
 - Special Note...AP English grows from 3 to 29 Qualifying Scores (+866%)
- 25 Scores of 4 or Higher (up from 13 in 2010)
