


On behalf of the residents of River's Edge Drive as well as Edgewater Drive, and the "Street Acceptance" Committee listed below, I am pleased to deliver to you the enclosed list of all twenty nine families with their initials indicating their support of betterments to pay for the costs to complete roadway work required in order for the town to accept these two streets as public roads. We understand these betterments will carry a twenty-year payback and that the town will recommend acceptance of the roads "as is" with these provisions, and will commence completion of necessary repairs as soon as the road is accepted.

We thank you for your interest and assistance in bringing this issue to closure through a process that will allow residents to pay for this work over time. Thank you for meeting with us and for guiding us in this direction. All who reside on these streets are eager to bring this issue to closure.

That recommendation is for the setup of a betterment to pay for the costs to complete roadway acceptance of the subdivision of Rivers Edge Drive and Edgewater Lane. This estimated betterment is a 20-year betterment of \$6,483 per household (\$39.29 per month at 4% interest).
