RE: Chapter 90

The current balance for uncommitted Chapter 90 funds for Middleboro is \$440,222. In addition, for active projects, I estimate that there will be \$50,000 in unspent funds for a total of \$490,222 in funds that are currently available.

Middleboro's FY14 allotment is estimated at \$1,300,000. Release of funds is expected soon. Our combined uncommitted funds and the FY14 allotment are estimated at \$1,790,222.


