Hi Tricia, just tried to call and the line was busy but wanted to touch base on the WRGC co-hold CR. We've gotten minor comments back from EOEEA on the CR. I have attached the tracked edits for the Commission. Two principal items: 1) because grant money is involved (state Conservation Partnership grant), we've had to get a review by Mass Historical Commission. That review is on-going. I'm hoping they clear the project area, but if they do not, Paragraph B(12) will look like the inserted text (the principal concern being digging). If MHC clears the project area, then archeology will be completely removed as a reserved right. I've inquired of MHC for an update and hope to have something to report by the meeting date of June 6; 2) the other big insert is Paragraph C. Because we have co-holders, there needs to be an approval process and time schedule spelled out. My oversight had the prior language for a single holder. I don't anticipate any issues in our figuring out approval responses between us and y'all, so there shouldn't be any issues. The other edits are self-explanatory.

So, this is the form of the CR that BBC has approved and that I'd seek approval from the Commission on June 6. WRGC meets June 4 and I expect approval. Have you heard anything from Town Counsel (?), as this would also be the form (with tracked edits accepted to create a clean copy) to put before the BOS on June 10. I have also attached the maps in case you'd like to have it for the Commissioners. Lastly, I think you wanted to be the one to forward things to the BOS in anticipation of the June 10 meeting (which is just great with me), so when would that need to be done?

Lots of info, I know. Call me when you can. I'm out at a meeting this afternoon from 130PM to 330PM.


