Subject: Chapter 90 Projects

The current balance for uncommitted Chapter 90 funds for Middleboro is \$119,545. In addition, for active projects, I estimate that there will be \$118,800 in unspent funds for a total of \$238,345 in funds that are currently available.

Middleboro's FY15 allotment is estimated at \$874,021. These funds have been released and will be available for use as of July 1, 2014. Our combined uncommitted funds and the FY15 allotment are estimated at \$1,112,366.

Since the anticipated pavement management plan is not yet completed and in order to begin scheduling contractors I would like to recommend the following projects be completed this year.

Below are anticipated project requests for 2015 as follows:

Fuller Street (Thompson Street to Joseph Robert)	\$227,250
Elm Street	\$42,030
Station Street	\$46,640
Wood Street	\$230,670
School Street	\$13,890
Old Center Street (Route 44 to Anderson Avenue)	\$132,750
TOTAL	\$693,230

Additional projects to be requested at a later date include the continuation of our crack sealing program, roadway drainage and surface design of Precinct Street, and guardrail replacement at several locations.
