Bob,  
Starting on October 1, 2015 the DPW will give the residential trash and recycling customers the option to purchase additional trash and recycling carts. It is my recommendation that we charge the following for additional trash and recycling carts:

- Additional recycling cart- \$50.00 one-time fee.
- Additional trash cart \$100.00/year billed quarterly

It is my opinion that we charge a one-time fee for the recycling bin in order to make the resident responsible for the cart. Also if we give the carts away we may ended up giving out more carts than we currently have in stock as residents may grab them just to have them.

The trash cart fee is yearly because of the cost associated with disposing the additional trash.

These fees should be brought to the BOS for their approval. They are aware of the \$100/year fee for the additional trash barrel but the additional recycling cart issue is something that has recently come up when we were handing out the carts.
