Meeting Minutes**

**September 14, 2015**

Chairman opened meeting at 7:00 PM by inviting those in attendance to join in the Pledge of Allegiance.

**MINUTES**

Motion made by Selectman Dalpe and seconded by Selectman Stewart to approve the 9/8/15 regular meeting minutes with correction that the 9/8 vote approving a 2<sup>nd</sup> Hand license for “Former Favorites” to be located at 11 Center Street had been unanimous.

Upon motion by Selectman Dalpe and seconded by Selectman Stewart, Board voted unanimously to approve the 9/8/15 Executive Session meeting minutes.

**WARRANTS**

Upon motion by Selectman Dalpe and seconded by Selectman McKinnon, Board voted unanimously to authorize the Chairman, or his designee, to sign Warrants for week ending 9/5/15.

**NEW BUSINESS**

Upon motion by Selectman Dalpe and seconded by Selectman McKinnon, Board voted unanimously to promote Police Sergeant Todd Bazarewsky to Lieutenant, effective 9/15/15 and to authorize Chairman to sign the Promotional Certification and Promotional list. Police Chief Perkins addressed Board.

David Bennett, interim secretary of Tourism Committee offered that he is in support of Glenn Montapert. Motion made by Selectman Knowlton and seconded by Selectman Stewart to appoint Glenn Montapert to the Tourism Committee. Three in favor. Chairman Frawley, opposed. Selectman Dalpe abstained.

Motion made by Selectman Stewart and seconded by Selectman Dalpe to approve the Social Media Policy. Selectman Knowlton offered that he thinks it should be more focused on Town sponsored social media. Town Manager offered that it does include Town-sponsored social media. Town Manager offered that he is the process of negotiating this into the Collective Bargaining Agreements. IT Director Tara Pirraglia addressed the Board. Discussion ensued. Four in favor. Selectman Knowlton opposed.

Upon motion by Selectman Dalpe and seconded by Selectman Stewart, Board voted unanimously to approve the I.T. Network/Systems Responsible Use Policy. Selectman Knowlton would like to see specific cutout for people using the computer at the Library and for the COA as well. Tara Pirraglia offered Labor Counsel's recommendation not to exclude individuals.

Chairman asked to hear any further questions. Hearing none, Chairman closed hearing. Upon motion by Selectman Dalpe and seconded by Selectman McKinnon, Board voted unanimously to approve.
