Board of Selectmen:



In the above-entitled matter, please be advised that on or about July 5, 2007 I filed on behalf of Manuel S. Rosa an application to transfer the wine and malt package store license from Ingrid Lochard, Manager of Dazamoe, Inc. d/b/a The Middle Store located at 758 Center Street, Middleboro to Mr. Rosa, d/b/a North Main Street Market. After a hearing it was sent to the ABCC for approval. It is my understanding that the Department of Revenue did not respond favorably on this transfer as a result of an outstanding obligation on the part of the seller, Ingrid Lochard, and thus this transfer could not be concluded. Through no fault of my client, he incurred the following fees and expenses even though he was unable to operate under this license:
