Dear Mr. Wong:

Please be advised that the Middleborough Board of Selectmen will hold a hearing on Monday, May 5, 2008 at 7:45 PM in the Selectmen's Meeting Room in the Middleborough Town Hall, Nickerson Avenue, Middleboro, MA to consider whether to modify, suspend, revoke or cancel the 2008 Alcoholic Beverages Liquor license held by Tiki Buddha, Inc., d/b/a Tiki Buddha Restaurant for premises at 10 Merchant's Way in Middleborough, MA.


The reason for the hearing is that it is alleged that on March 29, 2008 the licensee sold or delivered alcoholic beverages to two persons under the age of twenty-one years in violation of law. If there is satisfactory proof of the alleged events, such would violate Massachusetts General Laws, Chapter 138, Section 34 and Section 2.05(2) of Chapter 204 of the Code of Massachusetts Regulations (permitting an illegality on licensed premises).

You are invited to attend the hearing. You may be represented by counsel and present evidence at the hearing or otherwise be heard.

Enclosed please find a copy of the police report which details the alleged violations.



Chief Russell,

On 3-29-2008 I was on routine patrol and queried several vehicles at the Tikki Budda Restaurant (10 Merchant's way). Of the 5 vehicles that were parked in the parking lot (in front of Tikki Budda) 3 had registered owners that were not 21 yrs old. I then went into the establishment with Ofc Collins and Ofc Keaney and conducted a liquor check.

There were 3 underage patrons at the establishment. Of the 3 only 1 had a drink, I then spoke to the 2 males seated at the bar that were not 21 yrs old and both stated that they just were eating dinner. I then spoke to Peter Wang (bartender) who admitted to serving 1 bud light beer. He did not serve Whidden.

I then further spoke to and he admitted to having 1 beer. He also admitted that the Tikki Budda has the reputation of lax id for persons under 21 yrs old.


It should also be noted that gave the wrong DOB and when I checked the registry print out it was discovered that she had a DOB of. I then spoke to her and she admitted to being served CRANBERRY/VODKA from Wang.

Based on the facts that the Tikki Budda has the reputation of lax ID policies and the fact that there were 3 people underage at the bar (2306hrs) and 2 of three admitted to consuming alcohol at the establishment I recommend that some action be taken against the Tikki Budda.



After quering plates in the TIKI BUDDA I noticed of 5 vehicles 2 had registered owners that were not 21yrs old. I checked the building and no one was seated at any tables. All patrons were at the bar. I then went in w/Ofc Collins/Keaney and conducted a liquor check. The parties at the bar were:

The under aged parties (w/exception of ) were/did not have any alcohol in front of them. After speaking w and the bartender PETER WANG 12-24-1950 they both admitted to having 1 beer (BUD LIGHT). was drinking (CRANBERRY/VODKA) and gave the wrong DOB . After checking her vehicle ) it was discovered that she was not 21yrs old. apologized for giving the wrong DOB. I spoke with wang and advised him that he may be getting a call from SELECTMEN. Wang was also advised that the two ( ) were not 21yrs old and he would not serve them any alcohol. I will forward this for follow up.


