Dear Chairman and Board Members:

On June 27, 2008, I did a final inspection of the Tailwater/Reservoir Recovery Pond off Rocky Meadow Street (Map 045 Lot 675) Permit #04-01 and found this project to be in compliance with the plans dated May 24, 2004.

I would suggest that the Town require Mr. O'Connor to post a bond in the amount of \$7,500.00 until the vegetation on the south and east slopes of the reservoir are established.
